

STATE OF ALABAMA PROCLAMATION

BY THE GOVERNOR

WHEREAS a General Election was held in the State of Alabama on Tuesday, November 6, 2018, for the purpose of electing certain state and federal officers and for the purpose of ratifying amendments to the Constitution of Alabama of 1901;

WHEREAS section 17-12-17 of the Code of Alabama requires that all of the election returns sent to the Secretary of State must, within 22 days after such election, be opened and counted in the presence of the Governor, the Secretary of State, and the Attorney General, or two of them;

WHEREAS, on Tuesday, November 27, 2018, the election returns sent to the Secretary of State were, in the presence of the Governor, the Secretary of State, and the Attorney General, opened and tabulated; and

WHEREAS section 17-12-18 of the Code of Alabama requires the Governor to proclaim the results of certain elections as ascertained pursuant to section 17-12-17;

NOW, THEREFORE, I, Kay Ivey, as Governor of the State of Alabama, in accordance with the Constitution and statutes of the State of Alabama, do hereby proclaim the results of the 2018 General Election, as are on file and of record in the Office of the Secretary of State, to be as follows:
