The Alabama economic development team has laid a foundation for recovery



fter enduring a difficult 2020, I believe that Alabama has turned a corner and is firmly on the road to recovery. A key reason for my optimism is the hard work of the Alabama economic development team, which over the past few years has laid a foundation for job growth in the state.

The team's accomplishments in 2020 serve to reinforce my belief in this dedicated group of professionals. The results they delivered during the pandemic year are outlined in the latest installment of the New & Expanding Industry Report, an annual report card on the state's economic development performance.

The bottom line is this: In 2020, economic development projects brought over \$4.8 billion in new capital investment to Alabama, a figure made impressive by the challenges faced by our team. The projects include commitments for close to 10,000 new jobs in a wide range of industries in communities throughout the state.

Having served as the assistant director of the Alabama Development Office (now the Alabama Department of Commerce), I understand the importance of this work in spurring future growth. Economic development has been a pillar of my administration from Day One. That is not going to change. This report validates my conviction that Alabama's economy is on the right path to regain its pre-pandemic momentum.

Alabama's team overcomes pandemic challenges to deliver growth projects

he COVID-19 pandemic really turned the world upside down, and Alabama was not spared its harmful effects..

Before the pandemic, Alabama's economy was really firing on all cylinders, with record employment levels and the lowest jobless rates ever posted for the state. At the Alabama Department of Commerce, we were gearing up efforts to line up thousands of workers for new jobs in several industries. That changed overnight.

Fortunately for Alabama, the economic foundation we have built over the past several years has proved to be very resilient. Today, that solid framework is positioning us to make a full recovery as the pandemic's grip begins to loosen. We're once again firing up efforts to expand Alabama's workforce.

For Alabama's economic development team, COVID-19 interrupted our progress in 2020. But it didn't kill our momentum. As outlined in the 2020 New & Expanding Industry Report, Alabama attracted a robust \$4.8 billion in new capital investment last year, a higher level of activity than that of some recent pre-pandemic years.

Overcoming all sorts of challenges, the team completed 230 projects in 2020, setting the stage for sustained growth in key industries in both rural communities and large metro areas across the state. Most importantly, the activity means jobs are on the way for Alabamians at a time when they are critically needed.

As usual, much of the job creation is centered in Alabama's auto industry, which remains an important growth engine for

the state's economy. But growth is sparking in other sectors as well. This is especially true of distribution/logistics, with 2020 projects that will bring over \$500 million in new investment and at least 1,700 jobs to the state.

One growth project in particular stands out for me: SiO2 Materials Science invested \$163 million to expand production of its innovative vaccine vials at its Auburn facility in 2020. Today, Moderna is using these unique vials to distribute its SARS-CoV-2 vaccine, protecting Alabamians and people around the world while putting us all on the road to a speedier recovery.

Alabama's rural counties will also benefit from growth projects announced in 2020. The state's 40 "targeted" counties attracted projects valued at nearly \$615 million, with just under 2,000 new jobs, last year. One of these projects involves Resource Fiber, which is creating 111 jobs in Sulligent with a facility where it will manufacture engineered bamboo products for commercial uses.

These developments, along with many others, make me confident that Alabama's growth potential is looking stronger than ever in coming years.
